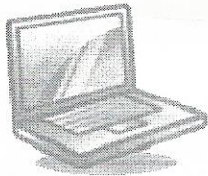

Just a few reminders

***Habitual parking on the street is prohibited -- this is a big one!!** Especially with summer and the kids being outside more.

***Keep lawn and garden areas free of weeds and attractive.**
